# **DELEGATIONS**

# Pat Finnegan – Napanee Detachment Commander - OPP

- The OPP respects the right of everyone to freedom of expression and peaceful assembly.
- The OPP also recognizes the rights of the general public, local residents and businesses to a safe environment.
- The OPP role is to ensure public safety and to keep the peace.
- The OPP has no role to play in the underlying issues (of the event) and is not in a position to resolve them.
- The OPP will work with groups who want to organize an event that provides a safe and peaceful opportunity for demonstrators to exercise their lawful rights.
- The OPP approach will recognize the need to balance individual rights and freedoms with the need to maintain public peace and order.
- Open communication, a reasoned and tempered approach and the proper use of police discretion guide OPP response to major events.
- The OPP asks everyone to be patient and respectful of each other despite potential inconvenience.
- Protest activities may interrupt the normal flow of traffic. The OPP is working with those involved to minimize the impact on the traveling public and to ensure order and public safety.

- The OPP objective in policing any road closures / blockades is to work to restore the orderly flow of traffic in the safest manner possible
- The OPP calls on everyone involved not to jeopardize public peace or endanger anyone and not to participate in purposefully illegal events.
- The OPP will act to preserve the peace, maintain public safety and investigate criminal wrongdoing, in accordance with legislated responsibilities and in the best interests of all involved.
- Only the level of intervention necessary to ensure the safety of all citizens and to maintain peace, order and security is used. The use of force is always a last resort.
- The proper use of police discretion is a valid, appropriate approach to de-escalating situations. The proper exercise of police discretion should not be confused with lack of enforcement. Police may wait for a lower-risk opportunity to arrest offenders rather than inflame a situation.
- Violence will not be tolerated. The OPP will respond to unlawful events in an appropriate and professional manner.
- Council expressed concern that we make great efforts to market our community as a fine place to live and these events hurt these initiatives
- Pat explained that we are not alone, over 60 protests have occurred in the past few weeks in Ontario and over 300 in Canada since the Idle No More movement started gaining traction

# Deputy Reeve Iain Gardiner

- Wished to congratulate Reeve Rick Phillips of his recent election as the Chairman of the Eastern Ontario Wardens Caucus (EOWC), by virtue of his position as Warden of Hastings County
- Spoke as a Library Board Member
  - Operations are running well and the Board is satisfied that the transition with the new CEO has gone smoothly
  - The Board is looking at offering more evening hours without increasing costs
  - The entire schedule is being reviewed so that operation can be best taken advantage of

# Reeve Rick Phillips

- Advised Council that he had been speaking with Chisholm's Lumber regarding the offer of some property for free at the north end of the Township if the Council wished to pursue the idea of a substation at the north end
- It appears that we would also be able to get the building supplies at a lower cost
- Asked Council if we should contact the other three municipalities in the area of Roslin (Tweed, Centre Hastings and Belleville) to ascertain interest in a joint/shared venture
- It was agreed that we would wait for the new Fire Chief to start, find his feet and then this idea could be explored in more detail
- If we are not interested in the lot(s) Chisholm would like to be advised so that they can make alternate plans
- We will attempt to get back with an answer by late spring
- Advised Council that in further discussion with Chisholm's that they have been approached to consider a hydroelectric project at the Chisholm's dam
- As the municipality has some experience in alternate energy, they had approached the Reeve for further insights into process and what may be involved
- The Reeve advised Chisholm's to write a letter to CAO, Steve Mercer who has been most involved and added that he would be able to provide as much information as he could
- Brought up to Council the ongoing matter of a dilapidated and abandoned house in the Township and what could be done
- The neighbours are concerned about a potential fire and also the unsightliness
- The CAO explained that our property standards by-law is not satisfactory to deal with this, it is a matter of private property rights, the owner pays their taxes in full, and all utilities such as hydro have been disconnected
- If youth enter the home it is a matter of trespass, and hence an OPP matter
- This leaves us with few options
- The CAO did offer though that once our new By-Law Officer was in place that we would revisit the file and see what can be done
