**DELEGATIONS**

**Verna Stephenson**

- Described the history of occupation in the area just east of Read Road on the 8th Concession road allowance.
- The property where she lives was first built in 1861, the road was used at that time
- In 1998 Council moved that this extension would be maintained year round and that Ms. Stephenson would allow a turnaround to be built so that the plows and other equipment could turn around
- Ms. Stephenson has three access points to her property
- The first access is to the home
- The other two are for agricultural purposes

- The plow in recent years have been plowing to the house entrance but not beyond to the agricultural entrances, and snow has in fact been piled beyond the driveway to the home making access to the farm entrances more difficult
- Summer bushing and grass cutting is becoming an issue
- Ms. Stephenson asked for assurances, without regular prompting, that this whole area be kept clear of snow, and brushed regularly as was agreed to in 1998.
- Council assured Ms Stephenson that every effort would be made to ensure that this was the case.
- The Roads Supervisor noted the concern and will see that the roads crew is made aware

**Malcolm Elston**

- Provided Council with a letter from the Reeve, dated November 23, 2005, which indicated that there would be some “non-structural” work be done to the Lonsdale Bridges where the snowplows had hit some of the railings
- Inquired why nothing yet had been done
- Council received the information
  
- Mr. Elston further left Council with a note asking why nothing has been done regarding the new “smoke –shack” and “tower” recently erected at the site of the quarry occupation
- The Clerk advised that the Council has no by-laws concerning business licensing, only the zoning bylaw
- The Clerk further advised that we have been in close contact with the OPP regarding this situation and that it was primarily a policing matter, and the issue was far greater than a tower or smoke-shack
- Councillor Brady spoke of tolerance being a necessary component to a satisfactory resolution to this very complicated situation
