Tanya Delaney – Quinte Waste Solutions

- Appeared before Council to provide an update on the disposal of electronic waste
- The Ontario government has designed a program for the disposal of electronic waste
- A draft was released in 2008
- There are three components to the program that came into effect of April 1, 2009
  - Collection
  - Transportation
  - Processing
- QWS is primarily in the collection business
- Presently electronic waste is dealt with at the communities Hazardous Waste events
- As the program is just being rolled out QWS may be a potential site for a pilot project
- The program needs to recognize the realities of small communities and QWS proposed approach would do this
- The private sector is now also starting to receive electronic waste – Sears has an event upcoming
- More information on progress towards pilot project and any other information will come forward when available
