# **DELEGATIONS**

# Ron Durkin - Helping Hands Food Bank

- The Helping Hands food Bank has been in continuous operation since 1991
- The Food Bank services both the residents of Deseronto and Tyendinaga Township
- The Food Bank is run by volunteers and is funded through donations
- The Food Bank is located in the basement of the Deseronto Lions Club
- Usage has increased significantly in recent years
- Last year alone usage was up 18%
- Just last week 850 people were services including 450 children
- Mr. Durkin listed many of the donators, including social groups, private citizens and the private sector
- Local school, and churches appear to contribute the most
- Mr. Durkin thanked Council for their contribution last year in relation to the bottle drive
- Mr. Durkin wished to thank Council and wanted to emphasize that the Food Bank, although located in Deseronto was available for residents of Tyendinaga Township
- The Council thanked the volunteer group for their fine and selfless efforts

# Mary Callaghan - Potential Severance

- Mrs. Callaghan was on the agenda as a delegation to ascertain Council's support for a severance where the frontage was quite undersized
- The Clerk explained to Council that he had discussed the matter with the Chief Building Official and the Hastings County Planning Department and this lot could be considered an in-filling lot under the Planning Act and that this request is very reasonable
- Council advised, that based on this information that they would be supportive of such a severance once formal application was made and when the application was officially circulated to Council for comment as part of the process
- Council reiterated that this would be approved as an infill lot and that special zoning may be required in order to recognize the reduced frontage

# **Blessington Rd Residents**

- Ms Leslie Buxton was spokesperson for the group
- The property standards concern is regarding 3148 Blessington Rd owned by Ms Charlotte Jackson
- The residents claim the property is in deplorable condition and only seems to get worse
- They first complained on October 22<sup>nd</sup>
- What is Council going to do to get the place cleaned up
- One of the residents has a house for sale across the road and a letter from the Real Estate agent was circulated indicating that potential sales had been lost due to this situation
- Photographs of the property were circulated
- The residents indicated that they were aware that illegal dumping on the property had allegedly taken place
- There was also concern brought forward for the many horses that are on the property
- Fire Chief Stan Laton was in the gallery and he also acts as By-Law Enforcement Officer and offered the following
- Our current property standards by-law is antiquated and only has a fine structure
- Our by-law needs updating in order to be enforceable in the way that the delegation wished
- Chief Laton went on to describe that these issues are dealt with over a long period of time and if any efforts were made for us or a third party to clean up the property that it would involve significant legal costs and associated court orders
- Chief Laton assured the delegation that he was working towards a solution but that it would take time
- There was also an issue brought forward in relation to dogs barking late at night and Chief Laton explained that he was working with Animal Control and that the issue was being dealt with
- The Council recognized that they took the groups concern seriously and that staff would be directed to make progress on the issue

- It now appears that our 2009 surplus is \$153, 347
- The clerk asked for the associated motions for commit this extra amount to recreation reserves

- Communities are going to have a difficult time getting volunteers to act in this capacity

- The Clerk via membership in the Hastings County Clerks and Treasurers Association, have a possible solution whereby certain Clerks can Act as the Compliance Audit Committee for other Hastings municipalities
- A resolution is required from Council to support this approach
